Call for selection for three prizes for Master's Degree theses in memory of Eng. Stefano Rigatelli financed by the Piedmont Region and promoted by the Department of Environment, Land and Infrastructure Engineering

THE EXECUTIVE

Having seen Legislative Decree 14 March 2013, no. 33, containing "Reordering of the discipline regarding the obligations of publicity, transparency and dissemination of information by public administrations" and subsequent amendments and additions;

Having seen Law 6 November 2012, no. 190, containing "Provisions for the prevention and repression of corruption and illegality in public administration" and subsequent amendments and additions;

Having seen Legislative Decree 29 March 2012, no. 68, containing "Revision of the fundamental regulation on the right to study and valorization of legally recognized university colleges, in implementation of the delegation provided for by article 5, paragraph 1, letters a), second period, and d), of Law 30 December 2010, no. 240, and according to the guiding principles and criteria established in paragraph 3, letter f), and in paragraph 6";

Recalling the Statute of the Polytechnic University of Turin issued by Rector's Decree no. 774 of 17 July 2019;

Recalling the Finance and Accounting Regulation of the Polytechnic University of Turin issued by Rector's Decree no. 1301 of 12 December 2022;

Considering the request for activation of three prizes for Master's Degree theses received from the Department of Environment, Land and Infrastructure Engineering (prot. no. 41650 of 11 June 2026);

Ascertained that the total cost of the benefit, equal to €3,000 gross of IRAP, is entirely financed by the Piedmont Region and is charged to funds managed by the Department of Environment, Land and Infrastructure Engineering (accounting project 58_AI_17SETRAJ)

DETERMINES

Art. 1 – Characteristics of the benefit

The Polytechnic University of Turin, following the request received from the Department of Environment, Land and Infrastructure Engineering, announces three prizes for Master's Degree theses in memory of Eng. Stefano Rigatelli, former Regional Director for Environment, Government and Land Protection.

The amount of each prize is equal to €921.66 gross for the recipient and net of charges borne by the University.

Art. 2 – Participation requirements

The selection is addressed to those who jointly meet the following requirements:

1. have obtained a Master's Degree in Environmental and Land Engineering (class LM-35) at the Polytechnic University of Turin between 1 January 2025 and 31 December 2025;
2. have developed a Master's Degree thesis relating to one of the following areas:
 - a. remediation of polluted sites;
 - b. environmental remediation;
 - c. asbestos;
 - d. mitigation and climate change.

Art. 3 – Compatibility

The benefit is compatible with:

1. scholarships granted by the Regional Agency for the Right to University Study (E.Di.S.U.) of Piedmont or by other regional or provincial bodies for the right to study;
2. other benefits deriving from other initiatives related to the right to study promoted by the Polytechnic University of Turin.

Art. 4 – Submission of the application

The application must be sent by 24 July 2026 through the online procedure Apply, available by connecting to one's personal page of the Teaching Portal in the section Career > Apply@Polito > Access new application > Choose path > Add application > Research and study grants > Degree prizes.

The following documents must mandatorily be attached to the application with size not exceeding 100 MB:

1. the Master's Degree thesis dissertation in PDF format;
2. presentation video of the work of maximum 4 minutes.

If a file exceeds 100 MB, the candidate must use the ticketing service according to the methods indicated in art. 10. In the ticket the candidate must indicate a link from which the document can be downloaded through services dedicated to large file downloads (for example WeTransfer).

To correctly submit the application it is necessary to fill in the application in all required fields, confirm the data and send the request in the section "Summary and confirmation". It is the responsibility of the candidate to verify the correct completion of the procedure.

The submission of the application implies full acceptance of what is contained in this call.

If the thesis has been prepared by several persons, all those who intend to compete in the selection must submit their own application. In case of winning, the prize will be paid divided into equal parts only to those who have submitted the application.

Art. 5 – Definition of the ranking and assignment of the benefit

After the deadline for submitting the application, the STUDIES Directorate – Access and Right to Study Office will verify possession of the requirements referred to in art. 2.1 and the presence of the attachments referred to in art. 4.

The evaluation of applications will be carried out by a commission composed of professors/researchers of the Polytechnic University of Turin and a representative of the Piedmont Region, whose judgment is unquestionable, according to the following criteria and related scores:

1. Originality of the thesis: for this criterion a maximum of 10 points may be attributed.
2. Completeness and relevance of the topics covered: for this criterion a maximum of 10 points may be attributed.

The application will be considered eligible if it has obtained a total score of at least 12/20.

If one or more members of the commission appear among the thesis supervisors of the candidate, the Commission will be supplemented so that the interested members may abstain from evaluation.

The benefit will be assigned to the first three candidates in order of ranking. If there are multiple candidates with the same score, priority in the ranking will be established by considering, in order, the following criteria:

1. higher Master's Degree grade;
2. higher weighted average calculated on the exams useful for obtaining the Master's Degree;
3. lower number of semesters of enrollment for obtaining the Master's Degree;

4. younger age.

The benefit will be divided into equal parts among multiple winners in the following cases:

1. upon exhaustion of the priority criteria described above, limited to candidates placed in the last useful position of the ranking for assignment;
2. the thesis has been written by multiple authors. The prize will be divided equally only among the authors who have submitted the application.

If the number of eligible candidates is lower than the number of benefits available, the benefit may not be assigned.

Following publication of the ranking, the winners will receive an email on their institutional email account.

Art. 6 – Acceptance of the benefit

The winners must accept the benefit according to the methods and deadlines indicated in the email referred to in art. 5.

In case of renunciation or failure to accept, the benefit will be assigned to the next eligible candidate in order of ranking.

If more winners are identified and not all send the acceptance communication or proceed with renunciation, the benefit will be assigned divided equally among those who have accepted it.

Art. 7 – Payment of the benefit

The benefit will be paid according to the payment method indicated by the winner in their personal page of the Teaching Portal in the section Career > Fees and payments > Payment method: therefore, the assignee must communicate, according to the methods and deadlines that will be indicated in the email referred to in art. 5, the data of the bank account on which the credit will be made.

The winner will also be required to fill in, in case there are other personal incomes in addition to the contribution provided by the Polytechnic, a document relating to deductions/detractions: the indications relating to the document will be detailed in the email referred to in art. 5. This operation is necessary for the purposes of determining the taxable IRPEF base and the application of deductions.

For tax purposes, the assigned benefit is subject to the current regulations on scholarships. The amount paid as a scholarship is income assimilated to that of employment and therefore has the same tax treatment.

Art. 8 – Personal data

Pursuant to the General Data Protection Regulation (Regulation EU 2016/679) and the Personal Data Protection Code (Legislative Decree 30 June 2003 no. 196) and subsequent amendments, the processing of personal data of the candidates is carried out by the Polytechnic University of Turin exclusively for institutional purposes and for transparency purposes imposed by regulations and will therefore be based on the principles of correctness, lawfulness and relevance for the same purposes. Art. 9 – Person responsible for the procedure
